FYI: Last summer, in compliance with the U.S. Environmental Protection Agency (EPA) and the Asbestos Hazard Emergency Response Act (AHERA) an inspection for asbestos containing building materials was performed at each of our Allentown Diocesan schools. A copy of the inspection reports is on file in each school's administrative office. Every 6 months regular asbestos inspections are made by our maintenance staff. These regular inspections insure the safety of all of our students.
